9. Election of Directors

Two valid nominations for the Board of Directors were received – those were Bec Fox (nominated by Fiona Coppin, seconded by Ray Buchanan), and Samantha Harris (nominated by Fiona Coppin, seconded by Bec Fox).

Two valid nominations were received for two vacant positions, so an election of Directors was not required. Bec Fox and Samantha Harris were elected unopposed for two-year terms expiring at the AGM in 2027.

Note - under the constitution, the Board of Directors must have a minimum of two representatives of Ordinary members, which is satisfied with Motorcycling Queensland (Ray Buchanan), Scouts Queensland (Peter Gould) and Australian Climbing Association Queensland (Samantha Harris).

10. Life Membership

Life Membership is the highest honour that Outdoors Queensland can bestow and Life Members will be held in the highest esteem.

Scouts Queensland has nominated Phil Harrison for honorary life membership of Outdoors Queensland.

Phil grew up in the outdoors, and has worked in voluntary and professional roles in the outdoor industry.

Phil is currently Principal of Tinaroo Environmental Education Centre on the Atherton Tablelands.

Phil has served many roles with Scouts Australia, including a 6 year term as Chief Commissioner of Scouts Australia.

Phil has been a member of Outdoor Educators Association of Queensland (OEAQ) since 1996, when he moved to Queensland for work, and is a long-time vice-president of OEAQ.

Phil also served on the board of the Outdoor Council of Australia for several years.

The Outdoors Queensland board has approved this nomination and referred it to this meeting for consideration of the members. Under the constitution, a resolution granting Life Membership needs to be passed by a majority of voting members at a General Meeting.
