Re: **Outdoors Queensland Annual General Meeting**

Dear Member,

The Outdoors Queensland Annual General Meeting (AGM) will be held from 6pm on Wednesday 18 March 2026. You are able to attend **in person** at Sports House, 150 Caxton Street, Milton 4064, or **online** via Teams.

We are also hosting an **Industry Forum** at 5 pm preceding the AGM. Please indicate if you wish to attend on the attached RSVP form. Please note that anyone can attend the Forum and stay on for the AGM but only financial members that have completed the Member Notification and Covenant form are eligible to vote.

All current financial member representatives are entitled to:

- Submit items for consideration at the AGM
- Be nominated for a position on the Board
- Nominate another financial member representative for a position on the Board
- Vote on the nominees to the Board at the AGM (if there are more nominees than vacant positions, a vote is then required)
- Attend and vote at the AGM.

Board members serve two-year terms, for a maximum of five consecutive terms, from the date of the Board Meeting at which they are appointed or elected. Directors must retire at the end of the AGM in the last year of their two-year term and shall be eligible for re-election (unless they have served the maximum term).

At the date of this notice, the board of directors is comprised as follows:

1. **Ray Buchanan** (representing Motorcycling Queensland) was elected at the AGM on 20 March 2024 (term expires at this AGM);
2. **Peter Gould** (representing Scouts Queensland) was elected at the AGM on 20 March 2024 (term expires at this AGM);
3. **Bec Fox** (representing Bec Fox Unleash Your Power) was elected at our AGM on 19 March 2025 (term expires at the AGM in 2027);
4. **Samantha Harris** (representing Australian Climbers Association (Queensland)) was elected at AGM on 19 March 2025 (term expires at the AGM in 2027);
5. **Andrew Boyle** was appointed 20 March 2024 (term expires 19 March 2026);
6. **Murray Stewart** was appointed on 19 February 2025 (term expires on 18 February 2027); and
7. **Graham Pringle** was appointed on 18 July 2025 (term expires 17 July 2027).

As noted, **Ray Buchanan** and **Peter Gould** were elected at the AGM in 2024, so their current terms expire at this AGM in March 2026.

Attached you will find relevant forms and a list of current financial members to assist in your nomination of an individual to the Board. Please remember that only members who are financially current are entitled to propose and second nominations, and vote.

Nominations close at 5 pm on **Wednesday 25 February 2026**.


